AMATUER WORKING DOG COMPETITION

Entrant Code of Conduct

1. The entrant shall not inflict verbal or physical abuse on any person.
2. The entrant shall not inflict pain nor cause wilful distress to any animal.
3. The entrant shall not engage in actions of dialogue which result in sexual harassment, discriminations or verbal abuse.
4. The entrant shall not engage in un-sportsmanlike conduct.
5. The entrant must present themselves for the competition in a state of sobriety.

Additional Terms and Conditions

1. The dog/s must have experience working with sheep.
2. The dog/s must have a recall.
3. If the dog/s tends to bite, it/they must be muzzled.
4. Gates must not be shut on the sheep
5. Dog boxes available for entrants to use to enclose their dogs.
6. Entrants may have permission to park on the grounds behind the competition arena if they have a suitable dog cage of their own.
7. Entrants must ensure that the dog has adequate water, food and shelter for the duration of their stay at the event.

Participating is strictly at your own risk, and you are solely responsible for your own safety. You must sign the registration form and in doing so, accept the following waiver and release of liability:

I hereby acknowledge that I am a responsible adult of 18 years or more in sound physical condition and myself and my dog/s are adequately trained for this event. I understand and accept the risks inherent in participating in the event. I agree to my own liability. I agree that no liability for my actions during this event shall be held by the McIntosh & Son Mingenev Midwest Expo, Board of Management, staff, volunteers, sponsors, organisation or individual or property owner or any affiliated entity with the working dog competition. I further understand that the McIntosh & Son Mingenev Midwest Expo does not carry insurance of any kind to cover me or my dog/s and if myself or my dog/s get injured or injure others or other property, I will take full responsibility and will waive all rights to file suit.

The judge's decision is final, and no negotiations will be entered into.
